

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to Sir perform the functions assigned to it, under NCH Act 2020. As per segtion 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations-made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant pennission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Purt-1 proforms were examined by the Medical Assessment and Rating Board.

2, On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the

 - After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, permission of the Medical Assessment and Rating Board is issued to Dhondumama Sathe (D.S.) Homoeopathic Medical College, F.P.No.23, Off Karve Road, Pune - 41004 for 100 seats in undergraduate course (BHMS) and MD (Hom) course in 04 subjects namely Materia Medica, Organon of Medicine, Repertory and Practice of Medicine with 03 seats for the academic session year 2021-22. The College Principal is directed to fulfill the deficiencies, provide documents and submit compliance report within 15 days.
 - All admissions in Under Graduate and Post graduate course shall be through NEET/AIAPGET only: It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining \$5% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted

All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter.
